Are You Looking for Secure Income in Volatile Economic Times?

Perhaps Braille Institute can help!

Our Charitable Gift Annuity program has provided hundreds of seniors a secure and profitable return on their money since the 1960's. Rates on Charitable Gift Annuities continue to be much higher than fixed-rate CDs or money market funds. (See Charitable Gift Annuity Rate table below.)

When these rates are compared, you can easily see that the Charitable Gift Annuity rate from Braille Institute is two to three times greater than other popular interest rate options. For example, an 85-year-old saver depositing \$50,000 in a one-year CD would receive approximately \$1,775 a year*. Using the same amount to fund a Charitable Gift Annuity with Braille Institute, this same person would receive an annual income of \$4,450—more than two-and-a-half times the CD!

In addition to this generous rate of return, a Charitable Gift Annuity offers other benefits:

- Guaranteed income for life unaffected by economic instability.
- A major portion of the income is completely tax free.
- A large income tax charitable deduction.

- Capital gains tax savings if funded with appreciated assets.
- The annuity income can cover the lives of two people.

And, many of our donors have found that the most satisfying benefit of a Braille Institute Charitable Gift Annuity is knowing that at the end of their lifetime, the remaining funds will support Braille Institute's vital free services for thousands of blind and visually impaired children and adults.

Grateful Great-Grandparents Plan Ahead to Help Themselves and

Several years ago, Keith and Earline Du Fault chose to fund a Flexible Deferred Charitable Gift Annuity with Braille Institute.

Unlike a traditional Charitable Gift Annuity, the flexible deferred option allowed them to make a gift and receive a current charitable income tax deduction, but postpone receiving their income stream until a later date of their choosing—each year they deferred their payments, their interest rate increased. This feature makes the flexible deferred variety a wonderful retirementplanning tool, as you can elect to begin receiving payments on your target retirement date. The Du Faults began receiving their income in the thick of the economic crisis in November 2008, giving them a fresh, dependable source of income for their lifetime.

Recently, Bob Pumphrey, one of Braille Institute's Planned Giving Directors, spent some time speaking with Keith Du Fault to find out what had motivated them to support Braille Institute in this way:

Bob: How did you initially become familiar with Braille Institute?

Keith: Well, we've been aware of Braille Institute for some time now. We would donate a small amount every year. We became much more familiar with the organization through our great-grandson, Devin. He's 19 years old now. When he was about 10 he lost vision in one eye. The doctors knew that eventually he would lose vision in his other eye. A couple of years ago, that's what happened.

Bob: And he began receiving services from Braille Institute?

Keith: Yes. Devin was going through a rough spot, adjusting to life without vision. He worked with the youth counselors who helped him a great deal. He began learning braille and entered the career training program at Braille Institute's Orange County Regional Center.

Bob: How is Devin doing now? **Keith:** He's doing very well. He's attending college. He's taken up music, which is amazing. He plays the guitar, he plays the drums, and he's learning the saxophone. Most importantly, he's become very aggressive about moving forward with his life since becoming a part of Braille Institute. It's given him a goal and a belief that there are so many opportunities for him after losing his sight.

Bob: Was there one event that you see as being a turning point for your great-grandson?

Keith: In fact, yes, there was. We were invited to attend the Braille Challenge™, an amazing event at Braille Institute's very impressive Sight Center in Los Angeles. There was a young man speaking, who was probably about 20 years old. He had already gone through many of the things Devin was experiencing at that time. And this young man was so terrific. He laid out the experiences in his life after losing his sight. I could see in the way that Devin was listening that the speaker had really struck a chord in him. And I think it made Devin a believer that he could do it, too. Seeing the great strides Devin began to make, my wife and I decided that if we were going to make a gift of any type, we would do it with Braille Institute because of all the fine work that they do.

Bob: How did you choose a Charitable Gift Annuity?

Keith: We did a little bit of research and got in touch with you. And you opened up our eyes to where we should best put our money not just to help Devin, but to help all the other people who are blind. When we saw and heard about all the people Braille Institute has helped, we were convinced. Every aspect of the organization is top-notch, from the services to the people to the facilities.

Growing up during the Depression in a single-parent household, California native Rosalyn Heyman learned early on what it was like to struggle. Yet through that struggle she developed a work ethic and an optimism that has inspired a lifetime of generosity.

As a young woman, Rosalyn put herself through UCLA, paying her tuition by working part-time as a skater and movie extra in Hollywood films. She continued her education, earning a master's at UCLA and graduating Phi Beta Kappa.

Rosalyn knew exactly what she wanted to do—shape young minds as a public school teacher. She was a natural educator, and within a decade Rosalyn became the principal of Berendo Junior High School, where she installed the first school computer lab in the nation. In 1982 Rosalyn was offered the position of Assistant Superintendent of the Los Angeles Unified School District.

Yet that glorious time in Rosalyn's life wasn't without challenges. "My mother had always had minor eye problems," Rosalyn remembered, "but around that time, her vision went downhill very suddenly. It was difficult for both of us."

Fortunately, Rosalyn found Braille Institute and introduced her mother to its Library Services and the world of talking books. "My mother had

been an avid reader her entire life," Rosalyn said. "The recordings brought her great joy."
